## 2020 Fair Educational Activity Requirement 4-H Dairy & Livestock Program

## For members exhibiting 4-H Dairy & Livestock and Consigned Market Poultry

- All non-Cloverbud members exhibiting beef, swine, sheep, goat, dairy, and market poultry at the county fair level are required to complete an educational activity requirement. Failure to meet this requirement will result in forfeit of fair premiums for species exhibited. Detailed information of the following requirements will be provided at market animal tag in or chick distribution and in future issues of the Livewire.
- **First and Second Year Exhibitors** of species listed above are required to participate in/attend two (2) pre-fair educational activities. Cloverbud exhibitor years do not apply. Opportunities to fulfill this requirement will be announced in the *4-H Livewire*. This requirement must be fully completed by June 15, 2020. This includes submission of the Dairy & Livestock Educational Activity Form for any activity requiring it, as indicated in the list of approved activities in the Livewire. A \$10 late fee will be assessed to exhibitors who complete this requirement between June 16, 2020 and June 23, 2020. Members who do not completely fulfil this requirement by June 23, 2020 will forfeit fair premiums for species exhibited.
- Third Year Exhibitors and More of species listed above are required to complete an ambassador program at the Hemlock Fair for each species exhibited. Cloverbud exhibitor years do not apply. The length of ambassador shift per species depends on the total number of species exhibited:

Number of Species Exhibited	Length of Shift/Species	Total Required Ambassador Hours
1	2 Hours	2
2	2 Hours	4
3	1 Hour & 40 Minutes	5
4	1 Hour & 15 Minutes	5
5	1 Hour	5
6	45 Minutes	5

- Approved educational activities are those listed in the *Livewire* or alternative activities pre-approved by the 4-H
   Animal Science Educator.
- Certain activities announced in the *Livewire* and alternate activities pre-approved by the 4-H Animal Science
  Educator will require a Dairy & Livestock Educational Activity Form to be completed and submitted for this
