

- All work must be that of the student on their grade level entry form for the 2024 year
- Parent/Guardian Authorization form (see below) must accompany <u>each</u> entry
- Winners from the previous year are not eligible
- Submit completed entry form **by 4pm on April 15, 2024** to your school's Main Office, the CCE Livingston County office, or via email to: trafficsafetycce@cornell.edu

Contest Awards & Prizes:

- Parents/guardians of winning entries will be notified via email or telephone by May 10, 2024
- Winners <u>must be present</u> for the **award ceremony** at **1pm on Saturday, June 1, 2024** during the **Livingston County Safety & Wellness Fair** at Livingston County Campus, Murray Hill Drive, Mount Morris.
- This year's contest will recognize:
 - 1 Creative Safety Showcase: Selected from the first and second place winners at each grade level. Exceptional entries should demonstrate creativity focused on safety, safety-related message or equipment. The winning entry receives a deluxe safety accessory package (in addition to their other prizes).
 - **8 First Place winners**: For highest quality entry by grade level. Winners will receive a certificate, new bicycle, helmet, and bike safety device.
 - **8 Second Place winners**: For highest quality entry by grade level. Winners will receive a certificate, helmet, and bike safety device.
