PLEASE BE SURE TO NOTE THESE CHANGES FROM THE 2023 BOOK & FAIR

- Building Exhibit Judging will take place in the Fair Festival Building on **Sunday**, **July 14th**, **1-5:30pm** (NEW TIME).
- Poultry Showmanship will take place on **Tuesday**, **July 16**th, **1pm**. NEW SHOW ORDER Fancy, Market, Master Showman.
- Fancy Bird Breed Show will take place on **Tuesday**, **July 16**th, **6pm**. NEW SHOW ORDER Fancy Bird Breed Classes Only. Exhibitors are not required to be present.
- <u>Consigned Market Poultry</u>: Exhibitors consigning market poultry only and no other species may sell 2 pens of 2 birds. Exhibitors consigning meat birds and another species may only sell 1 pen of 2 meat birds (NEW RULE).

TESTING AVAILABLE (FREE!)

Tuesday, July 2nd | 5-7:00pm Hemlock Fairgrounds

Registration Deadline: June 28th RSVP to Jenn at jls669@cornell.edu *Must provide the number of birds you will be bringing to be tested*

ALL POULTRY MUST HAVE:

1.) a negative pullorum-typhoid test conducted within 90 days prior to date of admission to the fair OR 2.) proof that the bird originated from a US pullorum-typhoid clean flock or equivalent flock. If utilizing a receipt, it must be dated within 1-year of the date of admission to the fair.

PROOF OF NEGATIVE TEST MUST BE SUBMITTED TO THE CCE OFFICE BY JULY 8TH

All birds must be tested with the exception of doves, pigeons, waterfowl, and meat birds purchased through the 4-H meat bird program. Birds purchased through the 4-H meat bird program will already have proof on file and need not be tested. **Birds four months of age and older are eligible for this test.**

If you have 10+ birds to be tested, it is highly encouraged that you contact NYS Ag & Markets to have a flock certification. Email Jenn (email above) for our state vet tech's contact information.



We all know good marketing strategies & techniques lead to higher product demand and higher product demand leads to higher sale prices. What are the marketing strategies and techniques 4-H'ers can use to increase the sale prices of their market animals? We will cover the strategies and techniques that will help members attain the highest sale price possible for their market animals:

- Identifying potential bidders
- · Creating your personal animal project story
- Developing a creative sales pitch
- Writing an effective introductory letter
- Making an impactful first impression
- Maintaining an ongoing personal relationship



This is a two-session program. The first will be an interactive session learning/practicing strategies and techniques you can use to market your project animal to potential bidders. The second will be a meet and greet reception with community members and local business. 4-H'ers will have the opportunity to talk with potential bidders, make their sales pitch, tell their story and receive constructive feedback directly from those who you make your pitch too. Whether you are brand new to the 4-H market animal program or this is your third year, these evenings will give you the tools you need to successfully market your market animal.

FAIR PREMIUMS AND CLUB \$ INCENTIVES AVAILABLE

4-H members (9 years or older) and adults are needed to help in the food tent during the fair. Responsibilities include maintaining a clean sanitary area, serving the public, taking food orders, counting change, and following the supervisors' directions. Four individuals are needed for each shift. Parent supervision is required for children 12 years old and younger.

INCENTIVES ARE AVAILABLE!

- Premiums will be awarded for multiple shifts completed.
- Work 6+ hours and receive a 4-H hat, bag, or t-shirt.
- Clubs that complete 3 2 hour shifts (6 total hours) will receive at least a \$150 incentive check depending on total sales during fair.

2 HOUR SHIFT SCHEDULE:

- Daily, Monday-Saturday of Fair
- 7-9am, 9-11am, 11am-1pm, 1-3pm, 3-5pm, & 5-7pm

HOW TO SIGN UP:

- Sign-up using the Fair Entry online system.
- Enter class 06 in Department 41 4-H Leadership Opportunities.
- Enter the class for each shift you would like to sign up for.
- After June 18th you will be able to schedule a shift(s) through a Google Doc that will be in the weekly email blast.
- After July 12th you will be able to schedule a shift(s) on a master white board in the 4-H Exhibit Building on judging day (July 14th) and at the food tent during the fair.

ATTENTION ALL HEMLOCK FAIR 4-H ANIMAL EXHIBITORS PRE-FAIR EDUCATIONAL ACTIVTY REQUIREMENT

All Dairy & Livestock and Small Animal exhibitors exhibiting at the Hemlock Fair are **required to complete one 45-minute animal-related educational activity by July 1**st. Cloverbuds are exempt:

- This requirement is for all members exhibiting at least one of the following species: Rabbit, Cavy, Poultry (Fancy & Meat Birds), Dairy, Beef, Goat, Sheep, or Swine
- Only 1 activity required regardless of the number of species being exhibited
- Failure to complete this requirement on time will result in forfeit of all fair animal premiums for the species listed above
- An activity can include any of the following:
 - 1. Any Livingston County 4-H Animal Activity Night participated in during current 4-H Year
 - 2. Participation in the Livingston County 4-H Public Presentation Program (MUST be an animal-related presentation)
 - 3. Any county, regional, state or Cornell University-sponsored 4-H animal science activities
 - 4. Independent 4-H animal activity pre-approved by a 4-H educator. A completed Pre-Fair Educational Activity Form must be completed and submitted with this option. Form may be found at http://ccelivingstoncounty.org/resources/pre-fair-educational-activity-form. Examples may include researching an animal-related topic of interest, attending an animal show, participating in a hands-on animal experience with a knowledgeable adult, watching videos/presentations on raising/showing an animal, etc. Contact Mark or Jenn regarding one of these ideas or if you have one of your own.

NYS 4-H VIRTUAL POULTRY JUDGING SERIES

MAY 8TH, 15TH AND 22ND

May 8th, 7 p.m. - Biology and Physiology of Production Hens

As hens move through their life phases, they experience a number of physiological shifts as their bodies prepare, sustain and eventually cease laying eggs. Learn what causes these changes and how to identify them. This information will be useful as students begin structuring their oral reasons.

May 15th, 7 p.m. - Handling Hens and Placing Classes

In this lesson, we'll use live examples of hens to review handling flighty birds and how to remove birds from cages. We'll also use examples of hens from red and white production strains to review how to place birds and how to back up those decisions with oral reasons.

May 22nd, 7 p.m. - Placing Classes Practice

Students will be given free online practice classes through livestockjudging.com to score and provide oral reasons on their own. This week's lesson will review the answers to those practice classes, provide the explanation as to why the classes were placed that way, and provide the opportunity for students to get their questions answered.

4-H Horse Program Reminders

Required Horse Show Paperwork Due June 1st

Reminder --- All horses and/or riders are expected to maintain a level of control and safety while in the ring at all county events (shows, practice riding sessions, clinics, etc.). Horses and/or riders that pose a safety risk while in the ring will be excused from the ring by the volunteer event chair or show judge. Re-entry into the ring during the event will be determined on an individual case basis.

Important Information:

- A completed 4-H Horse Certificate and copies of current coggins & rabies certificates must be submitted to the CCE Office by June 1st for ANY horse that may be shown during the show season. Consider having an extra horse on file in case something happens to your primary horse. 4-H Horse Certificates may be found at our county 4-H Horse Program Webpage.
- All members who are riding in a 4-H Horse Show are required to have a Riding Skills Evaluation completed and on file with the CCE Office by June 1st or prior to their first show of the season. Any member is who showing for the first time or wishes to "move-up" a level must be re-evaluated i.e.-Walk/Trot to Jr. or Sr. level or from Walk/Trot or Jog/Canter or Lope with no diagonals or leads to Walk/Trot/Canter with diagonals and leads. A member who has previously been evaluated to ride safely in Junior or Senior levels does not need to be reevaluated due to change of age from Jr. to Sr. Evaluation forms with complete information/instructions can be found at our county 4-H Horse Program Webpage.
- All 4-H Horse Shows will follow the rules outlined in the NYS 4-H Equine Show Rule Book. Livingston County 4-H Horse Shows will additionally follow the rules outlined in the Livingston County 4-H Horse Program Policy Guide. Both may be found at our county 4-H Horse Program Webpage.
- 10 qualifying non-mounted educational points, as specifically outlined in the in the Livingston County 4-H Horse Program Policy Guide will be required to qualify to ride in a mounted event at state but NOT at the county level.

All paperwork is due in the CCE Office for any horse you may be considering using at any county, regional, or state event. Please consider having an extra horse on file, just in case something happens to your primary horse.





New York Youth Livestock "Non-Ownership" Policy

The exhibitor, upon request to the event sponsor, shall provide proof of ownership of any exhibit.

This certificate verifies that a 4-H member in New York has enrolled this animal as a 4-H Project Animal by June 1st of the current year.

For all "non-owned" animals, the 4-H member and the owner of the animal have entered an agreement. A lease agreement allows a 4-H member to use the specified animal as a 4-H project. Cornell Cooperative Extension (CCE) encourages the use of written lease agreements, however, it is the responsibility of the exhibitor and the animal owner to agree upon the lease terms. Neither CCE nor Cornell University is legally involved in writing, implementing or terminating any lease agreements.

The following bill was legally adopted by the NYS Department of Agriculture & Markets July 1987.

Exhibits shall have been owned by the exhibitor for a period of at least (30) days prior to the entry of the exhibit provided, however, that any animal exhibit entered in a youth fair, youth exhibition or 4-H show or exhibition shall have been in the care of the exhibitor for a period of at least (60) days prior to entry of the exhibit.

CCE staff and state program administrators have maintained the following philosophy since 1987:

Non-owner/lease opportunities are intended for youth who do not already own an animal of this type. For exhibition purposes, youth are limited to one non-owned breeding class animal of this type.

Specific for Equine: The only approved NYS Horse Program exceptions are donkey, mule, miniature equine, and driving equine (used only for driving). In which cases a youth may own or lease an equine and also lease a donkey, mule, miniature equine, and driving equine (used only for driving).


